For US Taxpayers:

1. You can deduct your contributions to charitable (nonprofit) organizations like CMEx **only** if you itemize your deductions on Schedule A (Form 1040)
Note: You must have a receipt from the charity or a bank record for all charitable cash donations to claim a deduction on your tax return.
2. If you do itemize and give to a qualified charity, you can deduct cash donations and donated property, but you can't deduct the value of your time or service spent on charitable work. However, you can deduct your out-of-pocket costs for transportation, meals, boarding, etc.
3. The deduction for charitable contributions is limited to 50% of your adjusted gross income (AGI).
